Old Business:

Study of Integration Options for SJIEMS and SJCFPD#3:

Karin Agosta made a statement about the progress of this committee composed of herself, Commissioner Mark Schwinge, and community member, John Hinchcliffe. They have been conducting interviews of community members, town officials, and Fire officials about the past of SJIEMS when it was a part of SJCPFD, when it was separated from the fire district, and the future of where it fits best within San Juan County. When the interviews are concluded, the information will be consolidated and a white paper on the subject will be written.

New Business:

Res 16-452 EMS Amended 2016 Budget:

Chris Compton, CPA, Lake Kennedy McCulloch CPA's PS, presented the SJIEMS Amended 2016 Budget for approval. It is posted on the District website for review. Comissioner Williams asked for a motion to accept the SJIEMS Amended 2016 Budget. Discussion followed. It is based on the assumption that at least \$250,000 will be realized from the outstanding A/R that is listed from old accounts. On July 1, 2016, a new billing company, ESO, was contracted to take over from Intermedix. The ESO account information is not part of the statistics in this budget. Commissioner Williams called for a vote. Commissioner Schwinge Seconded the motion to accept the SJIEMS Amended 2016 Budget --- seconded by Commissioner Edwards.

Proposed SJCPHD#1 2017 Budget: Superintendent, Pamela Hutchins, presented the proposed SJCPHD#1 Budget to the Commissioners. It is posted on the District Website for review. The Commissioners will vote on its approval at the October 26, 2016, Board Meeting.
