CALL TO ORDER: Chair Michael Edwards called the meeting to order at 2:00 p.m.

## **SPECIAL MEETING BUSINESS**

Ongoing Discussion and review of Interlocal Agreement between EMS and Fire: The Board picked up where it left off on October 14<sup>th</sup> at section 6.1 in the Interlocal Agreement (ILA). Changes were proposed and recorded by Nathan Butler for inclusion in a new draft. Terms for separation, material breach, wind-up, hold harmless clause, the relationship between the hospital District Board and the Fire Chief, and other issues were discussed. The Board also discussed feedback from Richard Davis regarding changes to the two exhibits that make clear Interim EMS Chief Kuetzing is retained in his current role, and a new exhibit presented that clarifies the role of the Fire Chief in the agreement.

**Meet with Premera LifeWise Officials**: Three Premera LifeWise officials arrived to attend this meeting with the Board: Isabel Jones, Affordable Care Act Market Manager, Staici West, Director Health Care Delivery Systems, and Mia Wise, Medical Director for Collaborative Healthcare Solutions. They reiterated their long-term commitment to San Juan County and discussed their commitment to a workable solution for emergency airlifts. Dr. Loren Johnson made a brief statement at the invitation of the Board, and his statement is part of the permanent record.

Chair Edwards called a recess from 3:50 p.m. to 4:00 p.m.

**Review SJCPHD#1 2020 Budget**: Superintendent Hutchins introduced her 2020 Budget and reviewed changes to Revenue and Expenditures. Commissioners asked questions and discussed various aspects of the budget. The formal budget hearing will be October 23, 2019 at the Regular Board Meeting.

Review of the SJIEMS 2020 Budget was deferred to next week.
