CALL TO ORDER: Chair Edwards called the Regular Meeting to order at 2:00 p.m.

Time allotted was from 2:00 p.m. to 3:00 p.m., and ended up lasting from 2:00 p.m. to 2:40 p.m. Public session was resumed at 3:00 p.m.

Hutchins further stated that the District needs to formally submit a letter of commitment for a HRSA grant that will help with the development of a health network for long-term care, and presented a letter for review that does so.

He reviewed response times, finances, protocols, paramedicine, and reported that Joshua Corsa would be serving as supervising physician in the place of Olivia Haesloop.

PeaceHealth offer regarding Section 2.1.2.7 of the Subsidy Agreement: PeaceHealth has offered pay an additional \$5,000 beyond the current \$50,000 for the

next five-year term per section 2.1.2.7 of the Subsidy Agreement for a Combined Clinic and Hospital as amended by the 3<sup>rd</sup> Amendment subsidy on November 23, 2016.
