SJIEMS OPERATIONS REPORT: Karl Kuetzing, SJIEMS Chief. Chief Kuetzing gave his financial and operations report for December 2019, including some year-end data. The year 2019 ended with 100% of Revenue projections and 93% of expenses projections. There were 92 runs in December, for the entire year there were 1184 runs treating 1200 patients. Integration Steering Committee did not meet in December, but meetings are being planned. Full discussion of 2019 year-in-review was deferred.
