#### Financial Report

- <u>Cash Report</u> July total receipts posted by the county were \$13,441.48 of which \$13,441.48 were property tax revenues. Property taxes were up 98% from 2019 in July and YTD they are up 3% from 2019. Ending Cash Balance for July was \$800,490.61.
- <u>Disbursements</u> by the county totaled \$57,815.45 for accounts payable in July. YTD expenditures are .015% higher than last year currently.
- July had 0 records requests for \$0.00. This brings the total number of requests through July to 4 for 2020 costing district approximately \$500.00 for year to date.
- Review of Financial Performance of July 2020: Please see attached EDEN Revenue Detail Report, EDEN Monthly Financial Statement by Fund (Cash Balance), EDEN Expenditure Status Report, Outstanding Warrants through July 2020, and Warrant Summary for July 2020. EDEN Revenue and Expenditures by Fund is not showing correct data and the county has put in a work order to fix this problem so it is not included for July.

#### **Operational Report for July 2020**

The July reports were not presented at the August 26, 2020 regular meeting due to Superintendent Hutchins suffering a crushed wrist accident a few days before the meeting. They are now being presented at the September 23, 2020 regular meeting with apologies.

The public should pay close attention to the notices and agenda posted both in the papers and on the District website that tell how to access meetings held remotely. Governor Inslee extended the ability for us to continue to have remote meetings thru October 31, 2020.

The San Juan County Public Hospital District #1 has been talking about for quite some time needing to develop its own mission, vision, and values. These living documents are on our <a href="https://www.sjcphd.org">www.sjcphd.org</a> website.

On the Long-Term care front, SJCPHD #1 received the exciting news that the Care Coordination grant that was applied for back in March was awarded to Inter Island Healthcare Foundation, SJCPHD #1, PeaceHealth Peace Island Medical Center, and Association of Washington Public Hospital Districts. This grant is named San Juan County Community Based Long-Term Care Network (LTC Care Coordination Network Grant). It is a three-year grant just under \$250,000 each year. It was applied for before Covid-19 pandemic fully arrived so at the beginning some categories will undergo a change status with HRSA. The grant begins September 1, 2020 through August 31, 2021. This will be a great opportunity to further long-term care on San Juan Island and obtain information for the other islands in our county.
